# SYO -Use of our mapped areas for individual training.

All events, activities and training run by SYO will have permission from the land owners.

Sheffield is really fortunate to have a great deal of land that can be accessed by the public.

### All SYO maps state;

'Possession of this map does not imply right of access for orienteering or any other purpose. Permission must be obtained from the landowner. Representation of a path on the ground does not indicate a right of way.'

These are covered by bylaws which tell everyone what is allowed and not allowed, basically this does not exclude orienteering but no 'notices' are allowed to be fixed to anything, nothing may be damaged, all signs should be obeyed.

In addition please avoid all out of bounds areas marked on the newest map available, they are mainly ecological in nature and need to be respected.

#### Woodlands;

Sheffield has a tree strategy, the first line of which is-

"For all current and future generations to use and enjoy"

Ecclesall woods is very pressurised in terms of total footfall, we are only allowed events November to February inclusive. The out of bounds are to protect the crayfish! But also birdlife and ground flora are easy to damage especially in the spring.

Little Matlock wood Wheata wood Redmires –open access land Shirebrook Greno wood

Are not covered by the parks bylaws.

Think about not disturbing birds and ground flora particularly in the spring 1st March to 31<sup>st</sup> July.

#### Moorland areas:-

Bigmoor, Blacka moor, Burbage, Burbage mines, Ramsley moor, Cowms rocks These are covered by open access legislation;

People can normally access open access land on foot. They can: Walk, sightsee, run

However you must not play organised games or post notices.

They are all also sights of special scientific interest (SSSI). SYO will not get permission for events or training from  $1^{st}$  March to  $31^{st}$  July, to avoid disturbing ground nesting birds. Many also have the 'wet flushes' marked out of bounds to avoid paths being created in wet areas and destroying the vegetation.

Other open access areas include Wharncliffe, Wombwell, some of Haggside, Rivelin, Lady cannings. They are clearly marked on new OS maps.

# **Embargoes**

These mean that you should avoid areas that are being used for major events in the near future and you would have to declare yourself non competitive if you had trained on them if they appear on the embargoed list. ( it may not be fully up to date!)
